Report of Activities 2022

The Organisation international pour les Pays les Moins Avancés (OIPMA) - International Organization for the Least Developed Countries (IOLDCs) is a non profit, non-governmental and independent organization based in Geneva with ECOSOC status. Established in 1996, OIPMA, with particular focus on least developed countries (LDCs), advocates the fulfilment of Human Rights and acts as a bridge between civil society organizations and the UN Charter and Treaty Based Mechanisms for Human Rights protection and promotion.

The key priorities of the Organization are in line with the 2030 Agenda for Sustainable Development and the goals 1,3,5,13,16 and 17. In particular, conflict prevention, post -conflict peace- building, children in armed conflict and terrorism in crisis- affected LDCs and the impacts of climate change in LDCs.

Human Rights Advocacy: OIPMA's main objective is to highlight the challenges and difficulties faced by the least developed countries in the different international forums, especially those held in Geneva, with special relevance to the Human Rights Council. The organization tries to provide accurate and objective information on the countries that are part of its mandate, taking as a reference the Sustainable Development Goals, as well as other international conventions or treaties. On its website: oipma.org shares reports, written and oral statements from its participation in UN events and other events, forums or conferences of other international organizations or stakeholders with whom it shares common objectives.

Organization of events and programmes: OIPMA also organizes specific events to illustrate, with the help of experts in different fields, issues that it considers relevant, topical and essential to the achievement of its objectives. These events usually take place during the Human Rights Council and deal with issues related to the Council's agenda items. OIPMA regularly publishes its newsletter which includes summaries of its activities and information on events, resolutions or activities related to LDCs.
